As per the guidelines of Samagra Shiksha, Assam, there should be one Cluster Resource Centre Coordinator (CRCC) for each cluster covering both elementary and secondary education stage. The CRCC will be responsible for conducting the cluster level activities in accordance with the Govt. Notification No. E – 219473/34 dated 30/11/2022.

# **Eligibility Criteria:**

The applicant must fulfill the eligibility criteria as mentioned below:

- In-service Regular Teacher of Elementary Level/ Secondary Level (Excluding Subject Teacher/ Post Graduate Teacher) of the respective working district.
- 2. In-service Contractual Teacher under Samagra Shiksha, Assam

- (including State Pool Teacher) of the working district.
- 3. Teachers of the same medium can apply against the mediumspecific cluster.
- 4. Single -Hindi/Classical/Arabic/Sanskrit teacher of a school will not be eligible.
- 5. Teachers of Mathematics and Science will not be engaged as CRCC in any place.
- 6. Teacher of Single/Double Teacher school is not eligible.
- 7. Head Master/ Head Teacher/ Principal are not eligible.
- 8. Teacher from High PTR school shall not be eligible (In case of Lower Primary, PTR should not be more than 30:1, in case of Upper Primary, PTR should not be more then 35:1 and in case of High School, PTR should not be more than 40:1).
- 9. The teachers whose Schools have not performed well in Gunotsav (Grade C & below) are not eligible.
- 10. The maximum age is 45 years as on  $1^{st}$  January, 2023.
- 11. The maximum age is 50 years as on the 1<sup>st</sup> January, 2023 for the teachers who have already served as CRCC.

# **Essential Qualification**

- Graduation from UGC recognized University with NCTE-recognized professional qualification (D.El.Ed./ B.Ed. etc.). However, preference will be given to the intending Asstt. Teacher with Master's degree.
- In case of Dima Hasao, Karbi Anglong and West Karbi Anglong districts, the minimum qualification is Graduation from UGC recognized University. However, preference will be given to the intending Asstt. Teacher having D.El.Ed./B.Ed. etc.
- In case of Garo medium clusters of Kamrup and Goalpara districts, the minimum qualification is Graduation from UGC recognized University. However, preference will be given to the intending Asstt. Teacher having D.El.Ed./B.Ed. etc.
- Computer Literate (MS Word, MS Excel, MS PowerPoint, Internet browsing etc.).

## **Preference:**

- Preference will be given to the intending Asstt. Teacher with a Master's Degree and TET qualified intending Asstt. Teacher.
- Intending Asstt. Teacher with at least 5 years teaching experience as Asstt. Teacher in Govt./ Provincialized schools.

# **Important Point:**

- Candidates will be selected as per the Govt. Notification No. E 219473/34 dated 30/11/2022.
- In case of more than one teacher being qualified from same school, then the candidate securing highest mark will only be considered for attachment as CRCC.
- Candidature will automatically be cancelled on submission of any false/fake documents/information as and when detected.
- The authority reserves the right to decide the allotment of the cluster.
- The attached CRCCs shall not have any claim in future for absorption and continuation on attachment as CRCC under Samagra Shiksha beyond 5 years (maximum) from date of attachment.

- Date of selection test etc. will be notified in the same websites as well as Notice Board of respective DIET and DMO.
- The intending Asstt. Teacher should be energetic having social and leadership skills as well as capable of extensive school visits and tours on mission mode and organizing training/ workshops from time to time.
- Sorted out applicants shall be intimated to appear before the authority for verification of original document, any other supporting materials/ testimonial regarding his or her qualification and experiences as given in his/ her application.

**Financial Involvement:** The Asstt. Teachers to be engaged as CRCC will draw their salary against the parent post of teacher. No additional allowance or incentives shall be paid except for Contingency expenditure. This is subject to budget provision of Annual Work Plan & Budget (AWP&B) of Samagra Shiksha, Assam and further subject to availability of fund.

**Period of attachment:** The period of attachment as CRCC shall be maximum period of 5-years only subject to the satisfactory performance report to be submitted by the Principal, DIET of the concerned district. On the completion of the term or expiry of the period of attachment, the deed of agreement executed, if any, by and between the Samagra Shiksha, Assam authority and the attached CRCCs shall automatically be lapsed and the Asstt. Teacher attached as CRCC shall be repatriated to his/her parent post. The authority reserves the right to revert the selected CRCC(s) to their parent post/school in the interest of public service at any time, before expiry of the period of attachment.

**Submission of application:** The interested Asstt. Teacher will have to apply in specific format along with copy of the Working Experience Certificate and self-attested copies of all relevant supporting documents and one recent passport size photograph (Application Format and sample Working experience Certificate are uploaded at official website of SCERT and Samagra Shiksha, Assam). The duly filled in application should be submitted in the concerned DIET as per list enclosed.

# Last date of submission of application is 30th April 2024

Interested Asstt. Teacher will have to give option for their priority wise cluster within his/her working district in the application itself. Incomplete and incorrect application will be summarily rejected. Claims for correction will not be entertained once the application is submitted. At the time of interview/ verification of documents, intending Asstt. Teacher will have to produce all original documents. No TA/ DA will be paid for attending the verification, written test, interview etc. as and when called for.

In case of any irregularities observed regarding their eligibility/ efficiency/ punctuality/commitment in serving as CRCC in "Mission Mode", or any ineligibility detected as per terms of the advertisement even after attachment as CRCC, the authority reserves the right to terminate/discontinue their attachment at any time without assigning any reason thereof. CRCCs may be attached to other clusters in the interest of public service as per administrative exigencies.
